1hr - Check-in on the anticipated nature of the agreement  
30min - Review draft modeling decision matrix (as available)

**Day 2 - Thursday 8/22 (8:30am - 3pm, 1 hr lunch, 2 -15min breaks = 5hrs)**

15min - Recap  
Discussion of best practices for water quality trading for:  
    2hrs 15min - Permitting, compliance, and enforcement  
    1 hr - Monitoring, maintenance, and recordkeeping requirements  
    1 hr - Adaptive management and effectiveness monitoring  
30min - Action items, next steps, wrap up

Workshop #4 will be a catch all, cleaning up after the issues we haven't been able to resolve through tracked changes and comments. It is highly likely we will be discussing the transition into pilot phase and the nature of the agreement itself, but other than that there isn't a specific agenda at this time, nor is it likely to until after Workshop #3.
