Helen, I hope you had an enjoyable long weekend. Attached please find the current draft of the CIG proposal. We have several people working on this, so you may find it a bit choppy in places. Rough as it is, I think you will be able to get a good sense of the overall project plan. I did not include the budget documents with this draft. I wanted to make sure the content was right first. I hope this draft will help you better understand the proposal and enable you to write a letter that can be signed by your Director indicating Washington Ecology's willingness to participate.

Right now we are thinking that the grant would fund .5 FTE in each agency for three years. We are imagining that is roughly \$250,000, but would like to confirm with you when we start crafting the budget.

Please do not hesitate to call. I look forward to your feedback. As you will see from the proposal we are trying to build a system that ensures state flexibility.
