FYI, the permit document is a bit long, so you only need to look at pages 21-23 for the trading language itself, and pages 10-11 if you want to read about the reporting requirements. They have also posted on the regional trading project's document sharing website the actual contract between The Freshwater Trust and the City of Medford regarding the sale of the credits, but it is marked Confidential, so I won't attach it here but can help those on the water quality trading with how to access it.
